Class fees are as follows: Each class is \$16.00. Each Division is \$60.00. (A division is 4 classes)
***NWS Riders add School horse rental fee is \$30.00; this is a one-time fee for that day only for NWS Horses.**
Example: A NWS rider entering 3 classes pays \$16.00 X 3 + \$30.00 = \$78.00
A NWS rider entering 4 classes (one division) pays \$60.00 + \$30.00 = \$90.00

NORTHWESTERN STABLES (NWS) RIDERS:

We will make every effort to allow each rider the horse of his or her choice, however, the rider MUST list a second choice. Horses will be assigned based on the instructor's recommendation and availability. We will try to ensure the rider's comfort with the assignment, however please be advised these decisions are FINAL. There will be no switching the day of the show. If you don't list a second horse, one will be assigned to you. There are only a certain number of horses and we must be fair to them. This means no horse shall be ridden in all divisions.

ALL PARTICIPANTS: Registration is due by 2:00 pm on Saturday, May 15th. After that time the class fees will increase to \$18.00 per class. **All applications must be accompanied by a check payable to NORTHWESTERN STABLES. Without full payment, the application will not be accepted and you won't be registered.**

Please read carefully before signing:

If the participant has any medical problems that may be worsened or aggravated by horseback riding, a medical certificate is required before the rider participates. You should check with your doctor before this or any physical activities especially if you have not participated in physical activity for a period of time. It is recommended that all participants check with their doctor and have a tetanus shot.

In consideration of my being permitted to participate in this activity, I hereby for myself, my heirs, my personal representatives, assume any and all injuries that may be associated with this activity. I further waive all claims against and release, discharge, covenant not to sue and hold harmless the City of Philadelphia, Fairmount Park Commission, Northwestern Stables, Inc. operating Northwestern Equestrian Facility, and organizers, staff, agents and other representatives, any cooperating and coordinating individuals or agencies and any of their successors and assign in connections with any and all injuries, illnesses or damages of any kind whatsoever weather caused by negligence or other fault of the above agencies or otherwise. I certify that I am in proper physical condition to participate in this activity without rise of serious injury.

I also give the media my permission to use my name and picture by above agencies for any and all media.
